- 1. Vehicles qualified to display "Vintage" registration plates, Class L (Historic) Class N (Street Rod).
- 2. The "Vintage" registration plates must be issued in the same year as the model year of the motor vehicle.
- 3. Current Class L (Historic) Class N (Street Rod) registration plates must remain in the vehicle at all times when displaying "Vintage" plates.
- 4. The "Vintage" plates must be for a year not less than 25 years prior to January 1st of each calendar year.
- 5. "Vintage" registration plates are not transferrable to another person.
- 6. The "Vintage" registration plates must be brought to an MVA office which provides full service for verification and authorization.
